

## **Omni Táxi Aéreo awarded new contract with MAERSK to support operations in the Santos Basin**

Omni Táxi Aéreo announces the award of a new contract with MAERSK, one of the world's largest logistics and maritime transportation groups, for operations in the Santos Basin. With an estimated duration of nine months, the partnership marks the first contract made directly by MAERSK for offshore air transportation services in Brazil.

“Omni is recognized in the market for the safety and quality of the services it provides, in addition to its modern and large fleet of helicopters, which translates into flexibility for us to supply different demands. Adding a company of MAERSK's size to our pool of clients makes us proud and reinforces the efforts we make to build healthy, transparent relationships focused on customer satisfaction,” says Décio Galvão, Omni Táxi Aéreo's commercial director.

The contract with MAERSK foresees 14 monthly flights using the AW139, a reference in the offshore sector in the medium-sized category, with capacity for up to 12 passengers. The aircraft stands out for its high performance, combining operational range, fuel efficiency, high load capacity, comfort and robust safety ratings.

The AW139 model's configuration includes advanced technologies such as TCAS 2 (Traffic Collision Avoidance System), Tail Camera and Cockpit Camera, ensuring full compliance with International Association of Oil & Gas Producers (IOGP) standards. In addition, the aircraft allocated to this operation is zero kilometer, manufactured in 2024, offering even more safety and reliability to the mission.

As well as consolidating its presence in the offshore market, Omni Táxi Aéreo continues to invest in technology, innovation and safety, reaffirming its position as a reference in the sector.
